

2023 ANNUAL TOWN MEETING

April 11, 2023, ANNUAL TOWN MEETING was called to order by Town Clerk, Ada Owens at 6:00 o'clock P. M., at the Decatur Township Office Building, Upper Level, Community Room, 1620 South Taylorville Road, Decatur, Illinois. Owens announced the first order of business is to elect a Moderator. Nominations are now in order, Susie Tulak nominated John Funk and Bruce Pillsbury seconded the motion. Owens announced if there are any other nominations? John Funk moved nominations for Moderator to be closed and Bruce Pillsbury seconded the motion. A vote was taken to close nominations. The ayes are the clear majority and no nays by voice vote. Owens asked for a voice vote for John Funk to serve as Moderator. The ayes are in a clear majority. Owens announced John Funk will serve as Moderator of the meeting. Owens administered the Moderator's Oath.

The Moderator announced no person shall be allowed to vote or participate in this Annual Meeting unless he or she is an Elector in Decatur Township. An Elector is a person registered to vote within the Township no less than 28 days before the date of the Annual Meeting.

The Moderator announced the next order of business is the report of **Old Business**. Owens presented the Supervisor's Financial Report for 2022/2023 in written form. The moderator asks for a motion to accept the report as presented. Bruce Pillsbury made the motion to accept the report and Susie Tulak seconded the motion. A voice vote was taken. Majority ayes and no nays the motion carried.

New Business: Resolution to Audit: Thereupon Clerk Owens presented the following:

RESOLUTION

BE IT RESOLVED by the electors of the Town of DECATUR in the County of Macon, State of Illinois, an Annual Town Meeting assembled, this 11th day of April 2023, that the Board of Town Trustees of the Town of DECATUR are hereby ordered to hire a certified public accountant to audit the accounts of all town funds of which the Supervisor is Treasurer, in accordance with the laws of the State of Illinois.
Township Code 80-20 (60 ILCS 1/80-20),


The audit shall be made annually for the fiscal year ending immediately prior to the Annual Town Meeting. The audit, report and recommendations shall be filed as required by the laws of the State of Illinois, including a copy filed with the Township Clerk and another copy filed with the County Clerk.

Lisa Stanley made the motion to approve the Resolution and hire a Certified Public Accountant to Audit the Town's accounts and was seconded by Susie Tulak. A voice vote was taken, and the Moderator declared the results: Majority ayes and no nays the motion to Audit the Town's accounts carried.

The moderator announced the conclusion of the Annual Town Meeting. Bruce Pillsbury made the motion to adjourn, and Susie Tulak seconded the motion. The majority said aye and the meeting adjourns.
