RESOLUTION NO. 25 -

A RESOLUTION FILLING A VACANCY IN THE OFFICE OF TOWNSHIP TRUSTEE

WHEREAS, Decatur Township, Macon County, Illinois (the "Township"), is an Illinois Municipal Corporation existing and operating under the Illinois Township Code (60 ILCS 1/1-1, et seq.; the "Code") and the laws of the State of Illinois; and

WHEREAS, the Code (60 ILCS 1/60-5) provides that if a vacancy in the office of Township Trustee occurs, then the Township Board of Trustees ("Township Board") must fill the vacancy within sixty (60) days of the vacancy occurring, by appointment, and the person so appointed shall hold their respective office for the remained of the unexpired term and have the same powers and duties and subject to the same penalties as if having been elected or appointed for a full term of office; and

WHEREAS, the Code (60 ILCS 1/60-5) requires that any person appointed to fill a vacancy of Township office to be a member of the same political party as the person vacating the office if the person vacating the office was elected as a member of an established political party under Section 10-2 of the Illinois Election Code (10 ILCS 5/10-2); and,

WHEREAS, on Thursday, December 5, 2024, the Township Board accepted the written resignation of Township Trustee, Derrick Thaxton, creating a vacancy in the office of Township Trustee; and,

WHEREAS, after discussion and consideration, the Township Board desires to appoint whereas the consideration of the unexpired term vacated by former Township Trustee, Derrick Thaxton, and to serve as Township Trustee until a qualified and duly-elected successor is elected and is sworn into office.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP SUPERVISOR AND BOARD OF TRUSTEES OF THE DECATUR TOWNSHIP, MACON COUNTY, ILLINOIS, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Appointment to Office. The Township Board hereby appoints Rull a current Township resident, to act as Township Trustee for the remainder of the unexpired term vacated by former Township Trustee, Derrick Thaxton, and to serve as Township Trustee until a qualified and duly-elected successor is elected and is sworn into office.

Section 3. Acceptance of Appointment. Hy Sue Hereby accepts appointment by the Township Board to serve as Township Trustee for the remainder of the unexpired term vacated by former Township Trustee, Derrick Thaxton, and to serve as Township Trustee until a qualified and duly-elected successor is elected and is sworn into office.

Section 4. Severability. In the event a court of competent jurisdiction finds this resolution or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 5. Repeal & Savings Clause. All resolutions or parts of resolutions in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to Decatur Township, Macon County, Illinois, prior to the effective date of this Resolution.

Section 6. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval.
